The facts briefly stated are as follows:

On 21 Oct 16, Inmate Jeffrey Harris was in courtroom 504's lockup located in the Criminal Courts Building, 2650 South California, Chicago, Cook County, IL 60608. Inmate Harris used his body to push Deputy Sheriff [REDACTED] out of the doorway of the lockup. Security was called via radio. Deputy Sheriff [REDACTED], Deputy Sheriff [REDACTED] and Deputy Sheriff [REDACTED] arrived to assist D/S [REDACTED] regain control of Inmate Harris. Harris was handcuffed and then escorted to a maximum security cell. Harris placed his right foot on to the bars of the cell and pushed backwards in order to free himself from D/S [REDACTED] hold. D/S [REDACTED] regained control of Harris and as he was placing Harris into the cell, Harris spat at D/S [REDACTED] striking him on the forehead, left arm and uniform. After Harris was secured in the maximum cell, he stated that he would spit on D/S [REDACTED] again if he came near him.
