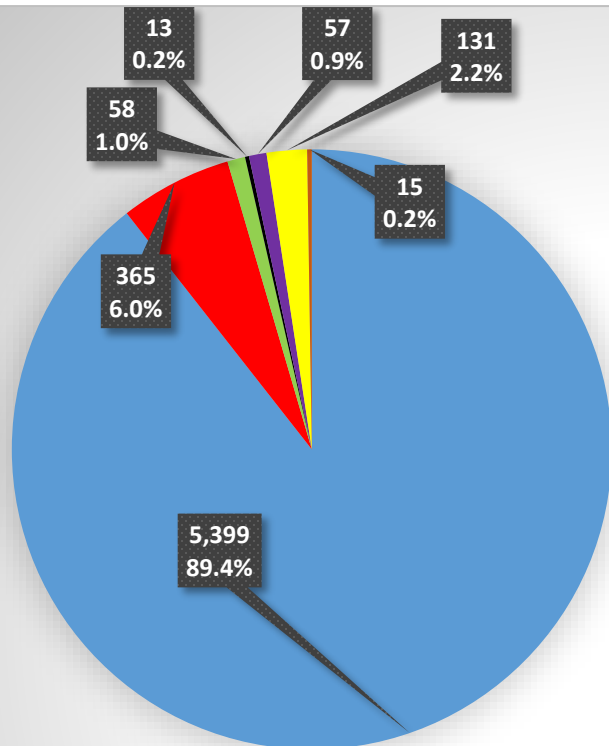

Detainees in court-ordered treatment programs (PRC, Women's Residential, VRIC) are housed at CCDOC 24 hours a day/7 days week.

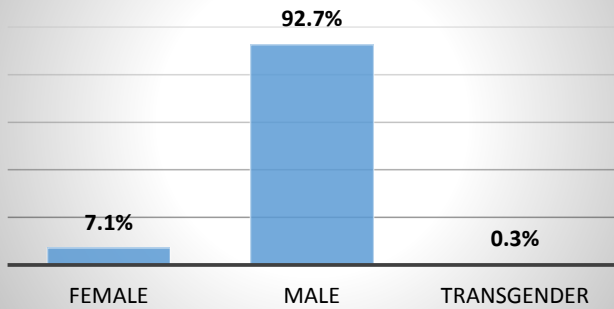

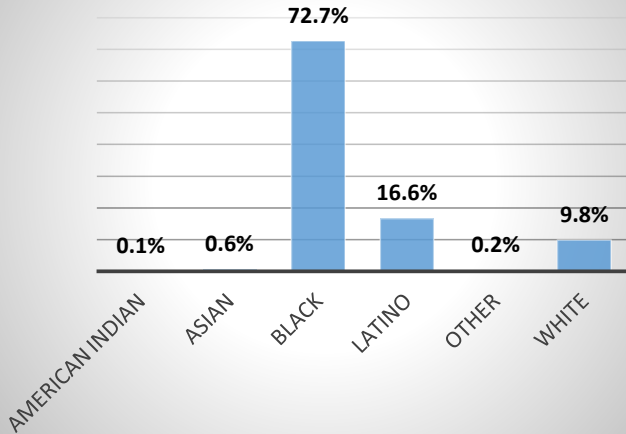
CCSO Population Demographics

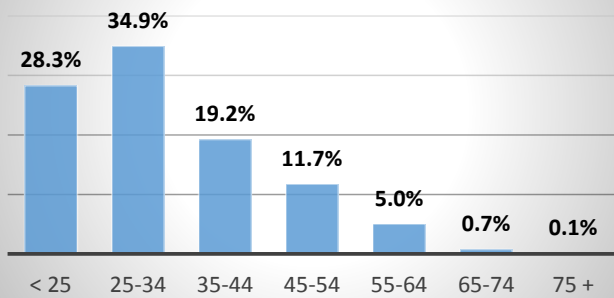
Gender Distribution



Race Distribution

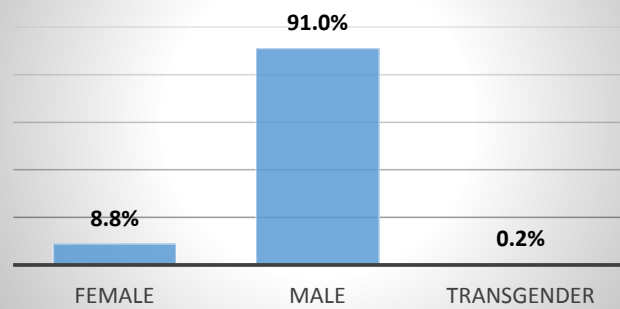


Age Distribution

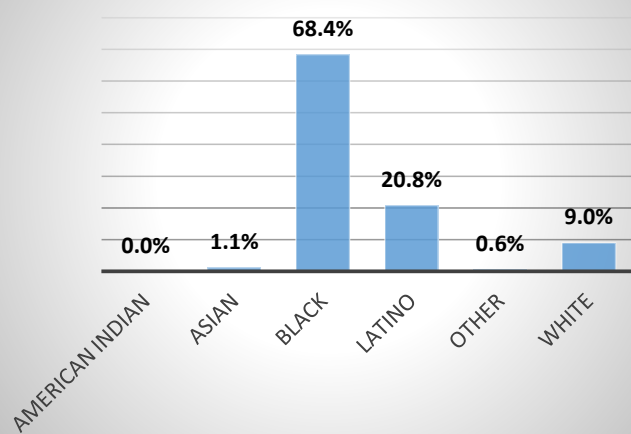

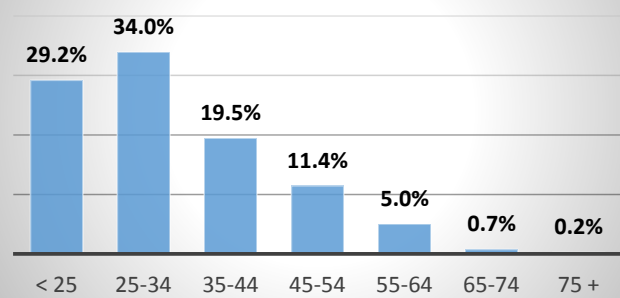
Gender Distribution
